## ELECTION

• Trustees **Jeff Miller** and **Ramon Garza** were sworn in during the June 7 Galena Park ISD Board of Trustees meeting. **Mike Parrott**, Harris County Justice of the Peace, administered the oath of office to Miller. Miller has served on the Board of Trustees since 1997. **Rev. Josefino P. Templado**, from Our Lady of Fatima Catholic Church in Galena Park, administered the oath of office to Garza, a 1986 graduate of Galena Park High School. This is the first term for Garza.

• **June Harris**, newly elected President of the Board, presented Jeff Miller, immediate Past President, with a ceremonial gavel for his year of service as President. **Wilfred J. Broussard, Jr.** was elected as new Vice President of the Board while **Joe Stephens** will serve as Secretary.
