Do You Want To Keep The Same Benefits for the New Plan Year? Then "Passive Enrollment" Is Just For You!

This means you will complete a few simple steps to keep all of your current benefits for the new year. Follow the instructions below <u>beginning July 10th</u> to complete your Passive Online Enrollment.

FOLLOW THESE INSTRUCTIONS ONLINE

- #1. Go to http://benefits.ffga.com/ISD and Enter your employer name
- #2. Your **User ID** is your Social Security Number
- #3 Your **Password** is the last 4 digits of your Social Security Number and the last 2 digits of the year you were born.
- #4. Once you are logged in you will see a Welcome Screen, press <Next>
- #5. Verify your dependents listed. Remember, you cannot cover anyone age 26 or older on any plan except for Texas Life unless the person is disabled.

If you need to make changes to one of your dependents, click on the <**Pencil>** icon on the right hand side of the name, and edit the information. Be sure to press <**Save>** once you are finished.

#6. You will now be on the *Benefit Summary* page. The list of products shown are the products you are eligible to purchase.

If you want to keep the product the same as you currently have press < **Keep Existing Election** > If you want to change the product, amount, who is covered etc., press < **Edit this Election** >, and make your edit's. Keep in mind if you no longer want a product, you must select < **Edit this Election** > and then select < **Waive** > to cancel enrollment in the product.

#7. Save your selections by entering your password in the Sign and Submit

Once you have selected all of your benefits the **Sign Forms Page** will display. All applications will be displayed that require an electronic signature. Your applications will appear as you click **Next**.

Review each form carefully. Some applications must be printed and signed in ink and returned to your benefits office, please be certain to read the instructions at the bottom of each application.

Follow the instructions by entering your **PIN**, click **<Next>** and/or **<Signing Form>**. **Sign/Submit Complete**


Are You Adding a Dependent That Was Not On Our Plan Last Year?

If you are adding a dependent that has not been on our plan in the previous year, you must provide the following item in order to add them to a plan:

1. Proof of Relation

- -Birth Certificate
- -Marriage Certificate
- -Common Law Certificate
- -Foster Care paperwork
- -Adoption paperwork etc.

2. Your Dependents Social Security Card



WHO CAN I ADD ON MY PLAN?

Under the Galena Park ISD insurance plans, only legal dependents may be enrolled. Legal dependents include:

- A child under age 26, who is one of the following:
 - ⇒ A natural child
 - ⇒ Adopted child or a child who is lawfully placed for legal adoption
 - ⇒ Step children
 - ⇒ Foster child
- ♦ A child under your legal guardianship
- Legal Spouse

- Common Law Spouse, with valid Common Law Certificate
- A grandchild whose primary residence is the household of the employee AND who is a dependent of the employee for federal income tax purposes

A child age 26 or over may be eligible for dependent coverage if the child is disabled. Please contact Employee Benefits if you believe your child qualifies for continued benefits past the age of 26.

Benefit Available on the "Employee Service Center"

Beginning September 1, 2017, you will be able to view all of your insurance benefits in the "Employee Service Center" on Teams.

Simply go to the "Employee Service Center" and select the "Benefits" option to view your current rates and coverages.

GPISD offers a 403(b), a 457, and Roth deferred compensation savings plans. You can join a plan anytime during the year.


The 403(b) and 457 plans are pretax savings plans, and the Roth plans are post tax savings plans.
