The Board of Trustees of Galena Park Independent School District met for a Regular Meeting on Monday, October 2, 2017 with the following members present, to-wit: Vice President, Wanda Heath Johnson; Members: Dawn Fisher, Wilfred J. Broussard, Jr., Joe Stephens, Ramon Garza, and Dr. Angi Williams, Superintendent of Schools. Geneva Boyett recorded the minutes. President, Jeff Miller and Secretary, Minnie Rivera were absent.

At 5:43 p.m., Vice President Wanda Heath Johnson stated that a quorum was present, and the Board would meet in Executive Session as authorized by Sections 551.001 through 551.084, et seg of the Texas Government Code pursuant to:
